1. Article I of the Articles of Incorporation of CCB Mediation, Inc. is amended as follows:

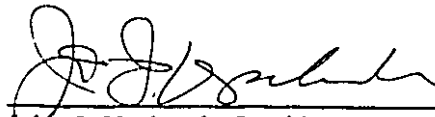
"The name of this corporation is: Upchurch Watson White & Fraxedas Mediation Group, Inc."
