The Articles of Incorporation of CCB MEDIATION, INC. were filed in Tallahassee, Florida on December 19, 1996. Articles of Amendment amending the name to UPCHURCH WATSON WHITE & FRAXEDAS MEDIATION GROUP, INC. were filed on June 5, 1997. Articles of Amendment amending the name to UPCHURCH WATSON & WHITE MEDIATION GROUP, INC. were filed on June 10, 1999. Article I of the Articles of Amendment to Articles of Incorporation of UPCHURCH WATSON & WHITE MEDIATION GROUP, INC. is hereby further amended to read as follows:

ARTICLE I
NAME

The foregoing amendment was adopted unanimously by the shareholders of the corporation by written action effective on the 1st day of February, 2002. The number of votes cast by the shareholders was sufficient for approval.
