
My name is Michael J. Woolbert, I am the president of P & T Nails Inc. We recently received a resolution of corporation letter from your office. On Monday morning October 22, 1997 at 9:00 A.M., I telephoned your office to explain the circumstances of our tardiness in this matter which was beyond our control. I was told to send this letter of explanation along with a copy of the Police report and a check for \$165.00 for your consideration in this matter.

We are a newly formed corporation created on December 20, 1996. At the time that our papers were filed by our Attorney, Irvin Shupack, Esq., we thought we had legally fulfilled our obligations. On Monday when I spoke to your representative ( I regret I did not ask her name) I told her that we had never received a first notice that our annual corporate report was due. She asked me if we had applied for one and I told her we were not aware we were supposed to.

We did receive the second notice and filled out the forms and enclosed the check, we wanted to return the documents certified mail, so my partner, Chi Le, took them home with the intention of going to the Post Office the following day after work (we both work at jobs separate from P&T Nails). Unfortunately the following morning his home was broken into, ransacked and robbed and among the items taken his brief case. Enclosed is a copy of the City of Margate Police Report. After the robbery, the following weeks were full of police reports, insurance claims and agents, contractors to replace the destroyed doors and windows, alarm companies with estimates and installation of alarm systems along with trying to calm the fears of his wife and two small children ages 3 and 6. During this time the report to be mailed which was in the brief case was simply and truthfully forgotten.

We would like to thank you in advance for your consideration and assistance in this matter.
