**ARTICLES OF INCORPORATION  
FOR  
P. DAVIS JANITORIAL SERVICES, INC**

THE UNDERSIGNED, being competent to contract and desirous of forming a For-Profit Corporation under the applicable laws of the State of Florida, submit the following as its Articles of Incorporation.

**ARTICLE I - NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this Corporation shall be P. DAVIS JANITORIAL SERVICES, INC. The principal place of business for the Corporation shall be : 6635 W. Commercial Blvd., Suite 219, Tamarac, Florida 33319.

**ARTICLE II - PURPOSE**

The primary purpose of this Corporation shall be to engage in providing janitorial and maintenance services to organizations, businesses, governmental entities, and other interested individuals, and to conduct any other business deemed legal and lawful in this State and in these United States.

**ARTICLE III -TERM OF EXISTENCE**

This Corporation shall have perpetual existence unless dissolved sooner by operation of law or by resolution of the shareholders.

**ARTICLE IV - OUTSTANDING SHARES**
