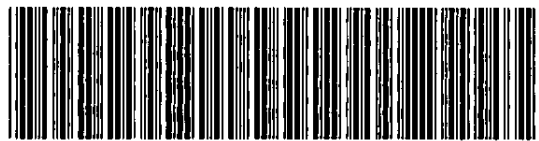

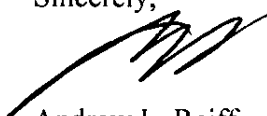

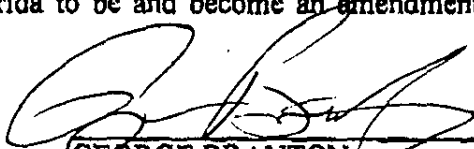

The date of adoption for these Articles is March 9, 2009.

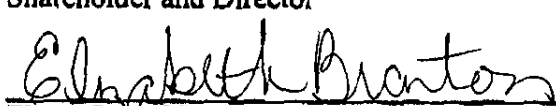

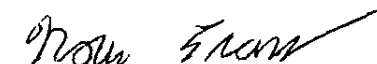

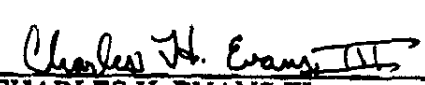
