**ARTICLE I - NAME**

The name of this Corporation is EAGLETECH COMMUNICATIONS, INC. and its address is 4401 W. Tradewinds Avenue, Suite 209, Lauderdale-by-the Sea, Florida 33308.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.


