ARTICLE I - NAME

The name of this Corporation is AUBERT PARTNERS, INC. and its address is
11767 S. Dixie Highway, #145, Miami, FL 33156.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws
of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK
