ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation shall be IRON EAGLE, INC,

ARTICLE II

This corporation shall have perpetual existence.

The primary purpose of this corporation shall be to engage in the general PURPOSE OF OPERATING A COMMERCIAL FISHING BOAT relating to operation of SHRIMPING AND OTHER RELATED COMMERCIAL FISHING BUSINESS and the transaction of any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

ARTICLE IV

The amount of capital stock authorized shall be two hundred (200) shares of common stock having a par value of Fifty Dollars (\$0.00) per share, making a total authorized capital stock of Ten Thousand (\$10,000.00).


