ARTICLES OF INCORPORATION OF
TASOS, INC.

The undersigned, acting as incorporators of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be TASOS, INC.

The principal address of the corporation at the time of incorporation is 10410 West Sample Road, Coral Springs, Florida.

ARTICLE II. DURATION

The duration of this corporation is *perpetual*, unless dissolved according to law.
