The undersigned subscribers to these articles of incorporation, personally competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is: The Rossam Group, Inc.

ARTICLE II

The corporation is to exist perpetually.

ARTICLE III

The corporation shall engage in the marketing, designing, and production and manufacturing of computer generated signage. The corporation may at any time also engage in other activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) shares of common stock having a nominal par value of (\$ 1.00 ) dollar(s) per share.

ARTICLE V
