ARTICLES OF INCORPORATION

OF

MID-STATE REBAR FABRICATORS, INC.

The undersigned, for the purposes of forming a corporation for profit under the Flerida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be MID-STATE REBAR FABRICATORS, INC.

ARTICLE II

COMMENCEMENT AND DURATION
