ARTICLES OF INCORPORATION

OF

MID-STATE REBAR FABRICATORS, INC.

The undersigned, for the purposes of forming a corporation for profit under the Flefida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be MID-STATE REBAR FABRICATORS, INC.

ARTICLE II

COMMENCEMENT AND DURATION

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence shall be effective with the filling of these Articles of Incorporation.

ARTICLE III

PURPOSE
