ARTICLE I. NAME AND ADDRESS. The name and address of this corporation shall be, CTI On-Line Services, Inc., and its principal office is located at 93351 Overseas Highway, Suite 3, Tavernier, Florida 33070.

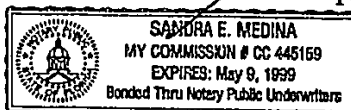
