The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is: HAVERHILL MANOR, INC.
The principle address of the corporation is: 1325 N. Haverhill Rd,
W. Palm Beach, FL 33417.

ARTICLE TWO

This corporation shall commence its existence on 1/1/97. * and shall exist perpetually thereafter unless sooner dissolved according to law.
