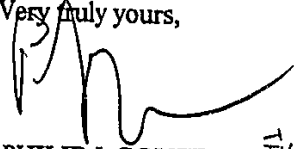

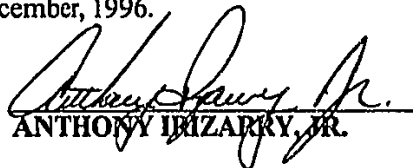
ARTICLE VIII - DIRECTOR QUORUM

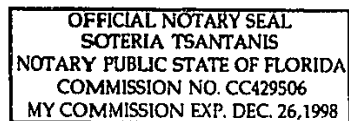

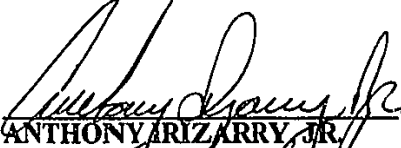
