**ARTICLES OF INCORPORATION
OF
CWF, INC.**

**ARTICLE I
Corporate Name**

The name of this corporation is CWF, Inc. and its principal office and mailing address is as follows: 1755 Branch Vine Drive, West, Jacksonville, Florida 33246.

**ARTICLE II
NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to operate a restaurant, to provide catering services and other culinary operations in the food and beverage industry and to engage in any other business activities which are lawful pursuant to the laws of the State of Florida and the United States of America.

**ARTICLE III
Capital Stock**

The maximum number of shares of common stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock having a \$0.05 par value. There shall be no other classes of stock.

**ARTICLE IV
Terms of Existence**

The Corporation shall have perpetual existence commencing upon the filing of these articles.

**ARTICLE V
Registered Agent and Initial Registered Office**

The initial registered office is at 1755 Branch Vine Drive, West, Jacksonville, Florida 33246. The name of the initial registered agent at that address is Matthew Medure.

The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.

**ARTICLE VI
Board of Directors**

The Corporation shall have two directors, initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one.


The persons named as initial directors shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first.


