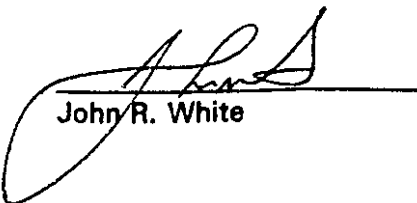

ARTICLE I - NAME

The name of the corporation is
JCK HOLDINGS, INC.
and the principal office address is
9401 S.W. 106 AVENUE
MIAMI, FLORIDA 33176

ARTICLE II - DURATION

This corporation shall exist perpetually commencing on January 1,
1997.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or
all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of FIVE
DOLLARS (\$5.00) Par value common stock which shall be designated
"Common Shares".

ARTICLE V - RIGHTS OF SHARES OF CAPITAL STOCK

Section 1. Dividends.

The directors may declare and pay dividends upon the Common Shares.

Section 2. Rights upon Liquidation of Dissolution.

In the event of any voluntary or involuntary liquidation, dissolution, or winding up of this corporation, the holders of record of the outstanding common shares shall be entitled to rateable distribution of the remaining assets.

Section 3. Voting Rights.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE XIII - POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE XIV - ACTION BY DIRECTORS WITHOUT A MEETING

The directors of this corporation may take action by written consent, as provided by law.

ARTICLE XV - DIVIDENDS

Dividends may be paid to shareholders only out of the unreserved and unrestricted earned surplus of the corporation.

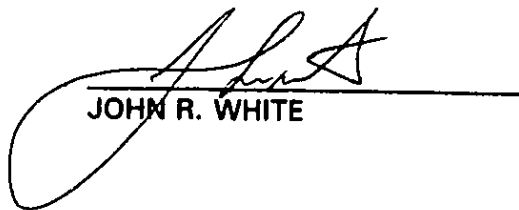
ARTICLE XVI - INDEMNIFICATION

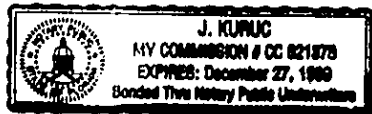

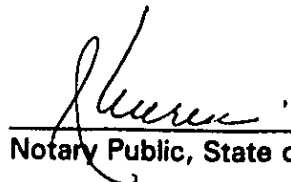

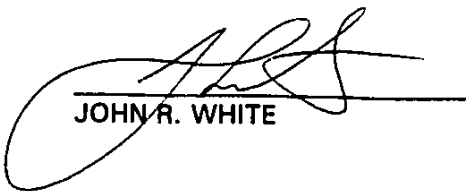
