ARTICLES OF INCORPORATION

"MONTANA, FRIENDS FOR LIFE, INC. 95 050 19 AH 8:4

The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME

The name of this corporation is "Montana, Friends for Life, Inc."

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the state of Florida.
