**ARTICLE I - NAME AND ADDRESS**

The name and mailing address of the Corporation is G.U.Z. Corporation and c/o Julio E. Manguart, Esq., 1428 Brickell Avenue, Main Floor, Miami, Florida 33131, respectively.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000,000 shares of common stock having a one cent (\$.01) par value per share.
