**ARTICLES OF INCORPORATION OF
PERSONAL WATERCRAFT EDUCATION AND TRAINING, INC.**

The undersigned, desiring to form a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation, liabilities, rights and privileges and immunities of corporations for profit, certifies that:

ARTICLE I - NAME

The name of this corporation is **PERSONAL WATERCRAFT EDUCATION AND TRAINING, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing at the time of filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and of the State of Florida, including but not limited to the instruction of boating safety.

ARTICLE IV - STOCK

This corporation is authorized to issue One Thousand (1,000) shares of common stock, each having One Dollar (\$1.00) par value, which shall be designated common shares.

ARTICLE V - PRINCIPAL OFFICE

The initial office of the principal office of the corporation is 2016 Lake Francis Drive, Apopka, Florida 32712.

ARTICLE VI - REGISTERED AGENT

The initial address of the registered agent of this corporation is 390 North Orange Avenue, Suite 1000, Orlando, Florida 32802, and the name of the initial registered agent of this corporation at that address is Michael R. D'Lugo.

ARTICLE VII - DIRECTORS

The corporation shall have two directors, initially. The number of directors, if necessary, may either be increased or decreased from time to time by the by-laws, but shall never be less than one (1). ARTICLE VIII - SUBSCRIBERS

ARTICLE IX - BY-LAWS

The power to adopt, alter, amend or repeal by-laws of this corporation shall be vested in the Board of Directors and the Shareholders.

ARTICLE X - DIRECTORS' COMPENSATION

The Shareholders of this corporation shall have the exclusive authority to fix the compensation of the Directors of this corporation.

ARTICLE XI - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the Shareholders is subject to this reservation.

ARTICLE XII - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XIII - MEETINGS BY CONFERENCE TELEPHONE

The members of the Board of Directors may participate in the regular and special meetings of the Board of Directors by means of conference telephone, as provided by law.

ARTICLE XIV - INFORMAL ACTION OF DIRECTORS

If all directors severally or collectively consent to any action taken or to be taken by the corporation and the writings evidencing their consent are filed with the Secretary of this corporation, then the action shall be valid as though it had been authorized at a meeting of the Board of Directors.

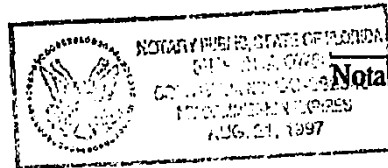
