ARTICLES OF INCORPORATION  
of

THE BUYER'S AGENT OF NORTHWEST FLORIDA, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is The Buyer's Agent of Northwest Florida, Inc.

ARTICLE II

The existence of the corporation shall begin on January 1, 1997.

ARTICLE III

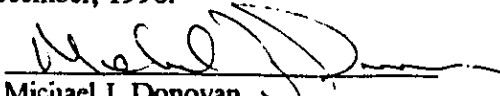

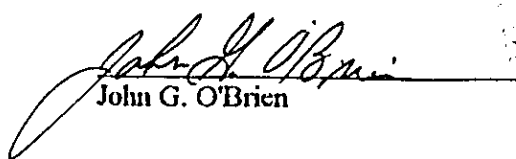
