

ARTICLES OF INCORPORATION  
OF  
SEVENTEENTH AVENUE CORPORATION

The undersigned, for the purpose of forming a Corporation under the the  
State of Florida in accord with Chapter 607 Florida Statutes, hereby adopts the  
following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is SEVENTEENTH AVENUE CORPORATION.

ARTICLE II - DURATION

The term of existence of the corporation is perpetual and shall commence  
upon the date of the filing of these Articles of Incorporation.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all

corporations may be incorporated under the Florida General Corporation Act and  
further to engage in all business matters necessary and proper in connection with

The power to adopt, alter, amend, or repeal By-Laws shall be vested in the Directors of the corporation.


ARTICLE IX - AMENDMENT

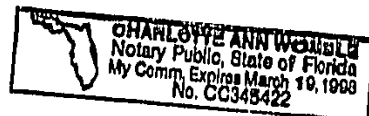


