ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. **NAME:** The name of this corporation shall be **GREATER HALIFAX AREA INVESTMENT COMPANY, INC.**

2. **DURATION:** The period of duration is perpetual.

3. **PURPOSE:** The purpose is to engage in any activities or business permitted under the laws of the United States of America and of the State of Florida.

4. **CAPITAL STOCK:** Corporation is authorized to issue 10,000 shares, all of one class at \$1.00 par value.

8. SHAREHOLDER QUORUM AND VOTING: Fifty (50%) percent of the shares entitled to vote, represented and in person or proxy, shall constitute a quorum and a meeting of the shareholders. If a quorum is present the affirmative vote of 50% of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

9. SHAREHOLDERS ARE AS FOLLOWS:

10. PRE-EMPTIVE RIGHTS: Each shareholder of this corporation shall have the right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in the corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of the issue bears to the total number of shares by any shareholder who does not exercise and pay for the share pre-empted within thirty (30) days of receipt of notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares and inviting him to exercise pre-emptive rights. The right may be waived by affirmative written waiver submitted by the shareholder to the

corporation.

11. **FORMAL ACTION OF DIRECTORS:** If any three (3) of the directors consent in writing to any action taken or to be taken by the corporation and the writings evidence therein consent filed with the secretary of the corporation, the action shall be valid as though authorized in a meeting of the board of directors.

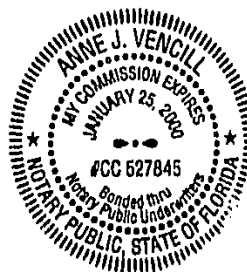
