

ARTICLES OF INCORPORATION
of
RCI FLORIDA, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1. NAME.

The name of the corporation is:

RCI FLORIDA, INC.

ARTICLE 2. PRINCIPAL OFFICE

The number of shares of stock that the corporation is authorized to have outstanding at any one time is one million (1,000,000). - (c) No director, officer, agent or employee of the corporation may apply to any court for an order requiring the corporation to provide indemnification or advancement of expenses pursuant to clause (9)(c) of section 607.0850 of the Florida Business Corporation Act.


