The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is HUNTER LACROIX COMPANY and its principal office and mailing address is 100 South Ashley Street, Suite 1270, Tampa, Florida 33602.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on December 17, 1996.

General Nature of Business

By-Laws

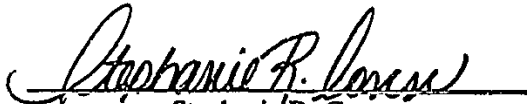
