Your letter dated 7-2-03 to the above taxpayer has been given to me for answering.

First, let me apologize for taking so long to respond to you. Your letter was dated 7-2 which is the day we left for a 3 week vacation. We returned last weekend and I am now getting to my telephone calls and correspondence.

In the fourth paragraph of your letter, you listed some fees, but I am having trouble in arriving at your total fee of \$1050.00.

Please let me explain some circumstances surrounding this account. The wife of the couple was responsible for filing these reports as well as other accounting functions. Each year we would ask if this report had been done and the response was that they had been filed. We did not check the internet or get a copy of the report. We accepted their word.

Recently the couple had a separation and the full ownership was given to the husband. When we asked about the Uniform Business Report for 2003, he did not know and asked that we check the internet. We did and found that the report had not been filed. The mailing address on this account shows 619 Uncle Jack Court, Orlando, FL, but the business moved from there about 3 years ago. So there is no telling where the forms might have been sent. They were not forwarded to the owners.

Since we did not have any blank forms, I tried to use a letter approach and send you the proper information with a check for \$150 which I thought was the fee for a corporation.


All of the above is said to ask for your help in resolving this matter. I am enclosing a proper form which you sent and returning the check for \$150. I ask that you please accept this payment and form and abate any reinstatement fees since no one got

the form and no one knew anything about it. We could pay the fee for each year but is the fee \$150 per year or \$61.25 per year. It appears that no report has been filed for 2001, 2002, nor 2003. So if you could accept this fee for 2003, then we can send you an additional check for \$300 for the other two years. No certificate of status is needed.
