OF

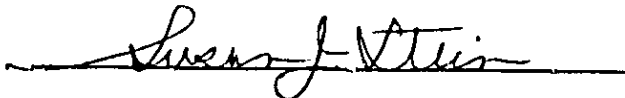

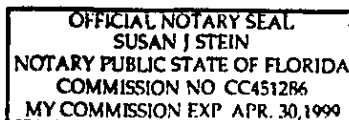

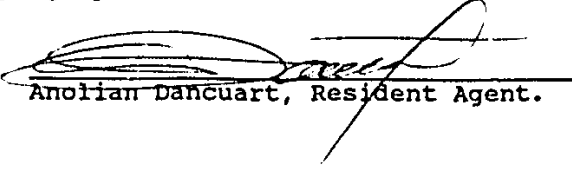
