ARTICLES OF INCORPORATION

ARTICLE I
NAME

The name of the corporation shall be WATERPROOFING, INC.

ARTICLE II
PURPOSE OF CORPORATION

The purpose for which the corporation is organized is to establish, maintain, and operate a waterproofing company in Okaloosa County, Florida, and to engage in such other activities as the Laws of Florida allow.

ARTICLE III
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 49 Poulton Drive, N.W., Ft. Walton Beach, Okaloosa County, Florida, 32548.

ARTICLE IV
CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value stock.

ARTICLE V
DURATION

This corporation shall exist perpetually and shall commence corporate existence on the date of the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE VI
PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which each already holds, shall have the right to purchase their pro rata share thereof (as may nearly be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII
INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of this corporation is 49 Poulton Drive, N.W., Ft. Walton Beach, Okaloosa County, Florida 32548, and the initial registered agent of this corporation at that address is JEFFERY L. ECKERT.

ARTICLE VIII
INITIAL BOARD OF DIRECTORS

The business of this corporation shall be managed by a Board of Directors. There shall be two (2) Directors initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one. 

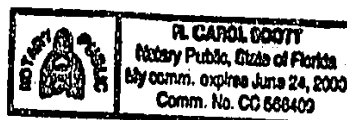
