

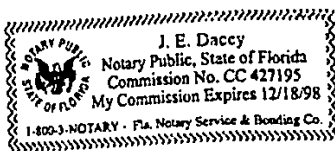



The name of the corporation is changed from Kireb International, Inc. to Working Warrior, Inc.



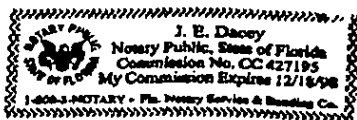


