# ARTICLES OF INCORPORATION OF

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

#### ARTICLE I - NAME AND ADDRESS

The name of the corporation is LEE FINNIGAN INTERIORS, INC., and its initial post office address and its principal office for conducting business is: 1811 North Tamiami Trail, Naples, FL 34102.

# **ARTICLE II - DURATION**

This corporation shall have perpetual existence, commencing on the date filed with the Department of State for the State of Florida.
