ARTICLES OF INCORPORATION FOR MUNSON COUNTRY CORNERS INC.

ARTICLE I: NAME

The name of this corporation is Munson Country Corners Inc.

ARTICLE II: DURATION

The duration of this corporation is perpetual.

ARTICLE III: PURPOSE

This corporation is organized for the purpose of transaction any or all lawful business.

ARTICLE IV: CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE VIII: PRE-EMPTIVE RIGHTS

Every stockholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share (as nearly as may be done without issuance of fractional shares) at the price as which it is offered to others.

ARTICLE IX: CUMULATIVE VOTING

At each election for directors, every shareholder entitled to vote in the election shall have the right to accumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing the votes on the same principle among any number of the candidates.

ARTICLE X: AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.
