

ARTICLES OF INCORPORATION OF GRAND AVENUE INVESTMENT COMPANY, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE NAME
