ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION 97 MAR - 6 PH 4: 04

FLORIDA IN-PATIENT RECOVERY SERVICES, INC. IALLANDE

LORDA

1. Article IV of the Articles of Incorporation of presently reads as follows:

DARTICLE IV

The aggregate number of shares which the Corporation shall have authority to issue shall be 10,000 shares of common capital stock, having a par value of \$.01 per share.

2. The following amendment to the Articles of Incorporation was adopted changing Article IV to read as follows:

*ARTICLE IV.

The maximum number of shares of stock which the Corporation is authorized to issue and have outstanding at any time shall be:

- A) 5,000 shares of Class A Common Capital Stock, having a par value of \$0.01 per share and an aggregate par value of \$50.00; and
- B) 5,000 shares of Class B Common Non-Voting Capital Stock, having a par value of \$0.01 per share and an aggregate par value of \$50.00.
- All of said shares of both classes shall have equal preferences, limitations and relative rights, except that the Class B Non-Voting Capital Stock shall have no voting rights what soever, either individually or as a class."
- 3. The amendment in paragraph 2 above was unarimously adopted by all of the Directors and a majority of each class of the Shareholders of the Corporation entitled to vote thereon as a class and the Shareholders of the Corporation pursuant to a Special Meeting of the Directors and Shareholders held on the 26th day of February, 1997.
