



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

The name of the incorporator to these articles of incorporation is Dennis J. Massengill, 4995 N US Highway 1, #71, Cocoa, FL 32927.


ARTICLE SEVEN
