ARTICLES OF INCORPORATION OF ALLIBRI ENTERPRISES, INC.

ARTICLE I. NAME

The name of this corporation is:

ALLIBRI ENTERPRISES, INC.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of engaging in any or all lawful business for which under the laws of Florida.
