ARTICLE OF INCORPORATION
OF

WE, THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF
INCORPORATION, NATURAL PERSONS, COMPETENT TO CONTRACT,
OF LEGAL AGE, BY THESE PRESENT HEREBY FORM A CORPORATION
UNDER THE LAWS OF FLORIDA.

ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE:

RAVEN FRUITS & VEGETABLES, INC.

ARTICLE II

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE, COMMENCING
UPON THE FILING OF THESE ARTICLES OF INCORPORATION WITH THE
DEPARTMENT OF STATE, STATE OF FLORIDA.

ARTICLE III

PURPOSE AND POWER

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF ENGAGING IN
ALL LAWFUL BUSINESS PERMITTED TO A CORPORATION ORGANIZED

ARTICLE IV

SHARES OF COMMON STOCK WITH NON PAR VALUE. THE CAPITAL STOCK OF
