

ARTICLES OF INCORPORATION

of

The undersigned incorporator and subscriber to these Articles of Incorporation, being duly licensed to engage in the profession of Realtor Associate under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation is JOLENE MILLS, P.A. .

ARTICLE II - PURPOSE

The professional service corporation is formed to engage in every phase of the profession of Realtor Associate. 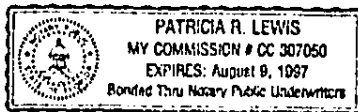
