I have been retained to handle the accounting for Glenn Friedly Sales, Inc. by Glenn C. Friedly sole shareholder. Mr. Friedly filed his Articles of Incorporation on December 20, 1996. They were file date stamped on December 23, 1996. With the articles he sent a check for \$ 70.00; \$ 35.00 for filing a new corporation and \$ 35.00 for Registered Agent Designation. His intent for filing at the end of December was to be legally incorporated on January 1, 1997.

I have enclosed copies of: the FEIN assignment showing the first form # 941 due by 4/30/97: the S-Corporation form showing January 1, 1997 as the corporation start date: the Florida Unemployment Compensation also showing January 1, 1997 as the start date.
