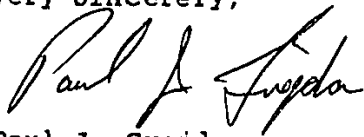

# Articles of Incorporation of

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is COPC International, Inc.
- SECOND:** The period of its duration is perpetual.
- THIRD:** The purpose(s) for which the corporation is organized are computer related components, sales, & marketing, import & export business of all types of items and the cleaning & janitorial business (commercial & residential) and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 1,000 of shares of common stock having no par value or amount of par value each.
- FIFTH:** The corporation will not commence business until at least One Thousand Dollars (\$1,000.) have been received by it as consideration for the issuance of shares.
- SIXTH:** Cumulative voting of shares of stock is not authorized.
- SEVENTH:** Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: None.

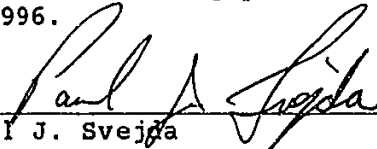

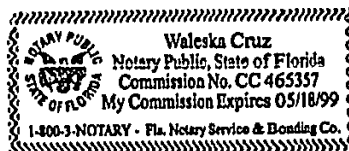
