**ARTICLES OF INCORPORATION OF  
GOOD SHEPHERD DISCOUNT CLOTHING, INC.  
a Florida Corporation**

The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I. NAME**

The name of the corporation is GOOD SHEPHERD DISCOUNT CLOTHING, INC.

**ARTICLE II. DURATION**

The corporation shall have perpetual existence.

**ARTICLE III. PURPOSE**

The corporation is organized for the purpose of transacting and all lawful business for which corporations may be incorporated in the State of Florida.

**ARTICLE IV. CAPITAL STOCK**

The corporation is authorized to issue one hundred (100) shares of all one class on One Dollar (\$1.00) par value common stock.

**ARTICLE V. PRINCIPAL OFFICE**

The street address of the principal office of the corporation is 5156 S.E. 20th Street, Ocala, Florida 34471, and the mailing address of the corporation is Post Office Box 1003, Silver Springs, Florida 34489.

**ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VII. INITIAL BOARD OF DIRECTORS**

The business of the corporation shall be managed by the directors, and it shall have two (2) directors initially. The number of directors may be either increased or decreased from time to time by the By-Laws of the corporation, but shall never be less than two (2). 
