# ARTICLES OF INCORPORATION OF LUCKY LEE RESTAURANT, INC.

hereby adopted by the

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator(s) of this corporation for pecuniary profit under the Floridad Business Corporation Act.

### ARTICLE I. NAME AND LOCATION OF AGENT AND OFFICES

#### **SECTION 1.1 NAME:**
