

ARTICLES OF INCORPORATION
OF ATTICUS, INC.

The undersigned, the President of ATTICUS, INC., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act, states as follows:

1. The name of the Corporation is ATTICUS, INC.
2. The Articles of Incorporation of the Corporation are amended by deleting Article I in its entirety and inserting the following Article I in its place and stead:

Article I – Name.

"The name of the corporation is ATTICUS HOLDINGS, INC."

3. The amendment to the Articles of Incorporation of the Corporation was approved by unanimous consent of the shareholders on December 18, 2002.
4. The Amendment was approved by unanimous consent of all of the shareholders entitled to vote thereon.
