The name of the corporation is CERTEX DENTAL STUDIO, INC.

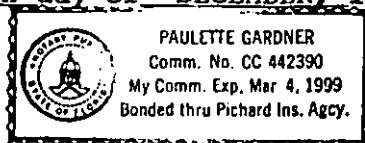
