The undersigned does hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purpose of foreating a corporation under the laws of the State of Plorida.

ARTICLE I - NAME

The name of this corporation is ULTRABRIGHT JANITORTAL SERVICES, INC.
