ARTICLES OF INCORPORATION

OF

T. G. BROWN, P.A.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a professional association for profit under the laws of the State of Florida.

ARTICLE I

The name of the proposed professional association is T. G. BROWN, P.A.

ARTICLE II

The general nature of the business to be transacted by this professional association shall be to engage in practicing law permitted under the laws of the United States and the State of Florida, and to have and exercise any and all other powers conferred by the Laws of Florida upon professional associations formed in the State of Florida.

ARTICLE III

The maximum number of shares of capital stock that this professional association is authorized to issue and have outstanding at any one time is 5,000.00 shares of common stock having ten cents (.10) par value per share.

The address of the initial office of this professional association is 324 Datura Street, Suite 312, West Palm Beach,

Florida 33401. The name of the initial registered agent at that address is T. G. BROWN, ESQUIRE.

ARTICLE IV

The amount of capital with which this professional association shall begin business is not less than Five Hundred Dollars (\$500.00).

ARTICLE V

This professional association shall exist perpetually unless dissolved according to law.

ARTICLE VI

The initial street address of the principal office of this professional association in the State of Florida will be 324 Datura Street, Suite 312, West Palm Beach, Florida 33401. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VII

The initial number of directors of the professional association shall be 1 (one). The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholder and authorized by law.

In case one or more vacancies shall occur in the Board of Directors by reason of death, resignation or otherwise, the remaining director shall elect a successor or successors to serve for the unexpired term of the director or directors, the absence of which created such vacancy or vacancies.

ARTICLE VIII


