**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
LAWEX CORPORATION**

Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida Business Corporation Act, as amended (the "FBCA"), the Articles of Incorporation of LAWEX Corporation, a Florida corporation (the "Corporation"), is hereby amended as follows:

- I. The Article labeled "Fifth" is deleted in its entirety and the following text is inserted:

Fifth: The total authorized stock of this corporation is 2,000,000 shares each with a par value of \$.001.

The foregoing amendment was proposed and duly approved by the Corporation's Shareholders and Board of Directors by joint unanimous written consent in lieu of a meeting on June 30, 2000, pursuant to Sections 607.0704 and 607.0821 of the FBCA. The number of votes cast for the amendment was sufficient for approval.

In accordance with Section 607.0123(1)(b) of the FBCA, this Amendment shall be effective upon its filing with the Florida Department of State.
