**ARTICLES OF INCORPORATION
OF
JOHN J SILVIA INC**

**ARTICLE I
NAME**

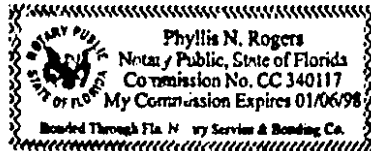
