The undersigned incorporator hereby forms a corporation under Chapter 621 of the laws of the State of Florida and does hereby adopt the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation shall be Georgia Hudson, P.A. The principal place of business of this corporation shall be 1350 Park Lake Drive, Naples, Florida 34110 and the mailing address shall be the same.

**ARTICLE II. NATURE OF BUSINESS**

This corporation is formed:

- (a) to engage in the sale, renting and transferring of property for others as a real estate brokerage business;
  - (b) to buy, sell, own and hold, lease and transfer and improve real and personal property;
  - (c) to engage and render the professional services involved only through its officers, agents and employees who shall be in good standing and duly licensed or otherwise legally authorized within the State of Florida to render real estate brokerage and sales services;
  - (d) to have all other powers and privileges that may be deemed useful or incidental to the carrying on and operation of any or all of the aforesaid businesses; and
  - (e) to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten thousand (10,000) shares of common stock having one dollar (\$1.00) par value per share.

**ARTICLE IV. REGISTERED OFFICE AND AGENT**

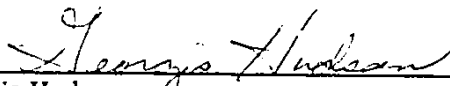
