HIERING ENTERPRISES, INC.

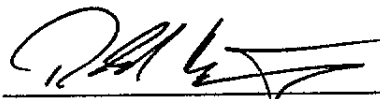
SECOND: The date of the amendment's adoption is this 20th day of March, 1998.
