ARTICLES OF INCORPORATION

EFFECTIVE DATE

OF

RAMEY'S FEED COMPANY

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of the corporation is Ramey's Feed Company.
- 2. TERM. The corporation shall exist perpetually. Corporate existence shall begin January 1, 1997.
- 3. PUPPOSE. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
